She also expressed how important it is that the public only be given factual information, and that the successes of the District over the past several years should be highlighted, paint a positive picture! Explain to the public what we are able to do today, what we would like to do better and what that would cost them in increased taxes. She believes the levy is a necessity, but the public deserves accurate information to base their decision on when they go to the polls.
