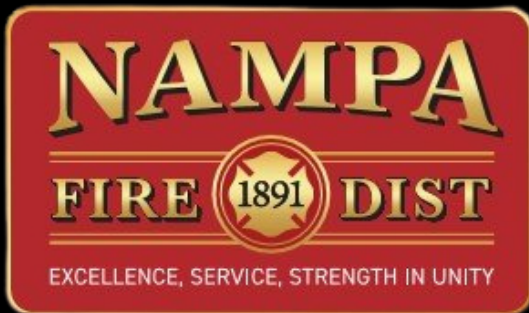

# POSSIBLE SHARED EXPENDITURE OPTIONS

Category	Nampa Fire	Kuna Fire	Approximate Difference
Annual Budget	Approx \$22M	Approx \$5M	Nampa = 81.5% / Kuna = 18.5%
Fire Stations	6	1	Nampa = 86% / Kuna = 14%
Population	Approx 120,000	Approx 30,000	Nampa = 80% / Kuna = 20%

## SIMPLIFIED ALLOCATION PERSPECTIVE

Basis	Approximate Split
Budget-Based	81.5 / 18.5
Station-Based	86 / 14
Population-Based	80 / 20

- Consider Approval of new District Name to be used in the Consolidation Agreement

# SUGGESTED CONSOLIDATION TIMELINE / BOARD ACTION FLOW

## SEPTEMBER 2026

### REGULAR COMMISSIONER MEETINGS AGENDA ITEMS

**Kuna (September 9, 2026) and Nampa (September 14, 2026)**

- **PRESENTATION**

- Consolidation Agreement Draft Ready for Review

- **PROPOSED BOARD ACTION ITEM**

- Consider Approval of Proposed Consolidation Agreement Draft to Proceed to Public Hearing
  - Public Hearing must occur not less than ten (10) nor more than thirty (30) days after approval pursuant to Idaho Code
- Consider Public Hearing dates one week earlier than usual Regular Meeting - October 5<sup>th</sup>, 2026 for Nampa and October 7, 2026 for Kuna.
- Consider changing Regular meetings from October 14<sup>th</sup> for Kuna to October 7<sup>th</sup> and October 12<sup>th</sup> for Nampa to October 5<sup>th</sup> to hold regular meeting after Consolidation Public Hearing.

### TO-DO

- Publish Notice of Public Hearing in Paper - Must publish at least 5 days prior to the hearing
- Prepare Internal Understanding Memo ready to disseminate if Draft Consolidation Agreement is Approved.

# SUGGESTED CONSOLIDATION TIMELINE / BOARD ACTION FLOW

## OCTOBER 2026

### PUBLIC HEARING & REGULAR COMMISSIONER MEETINGS AGENDA ITEMS

**Kuna (October 7, 2026)** and **Nampa (October 12, 2026)**

- **PRESENTATION**

- Consolidation Agreement Presentation to Public

- **OPEN PUBLIC HEARINGS**

- Conduct public hearing(s) regarding proposed consolidation agreement
- Receive public testimony and comment

- **CLOSE PUBLIC HEARING**

- **PROPOSED BOARD AGENDA ITEMS**

- Consider Final Approval of Consolidation Agreement
- Boards should consider whether they plan to hold their regular Commissioners Meetings
  - Nampa Regular Commissioner Meeting would be November 9, 2026
  - Kuna Regular Commissioner Meeting would be November 11, 2026 for Kuna.
- Consider setting a joint Board of Commissioner Meeting Regular Meeting Date for November 16, 2026 at 6 pm.

### **POST APPROVAL WAITING PERIOD**

Idaho Code § 31-1413(2), "If each board approves the agreement of consolidation, the agreement shall become effective and the consolidation of the districts complete thirty (30) days after the approval unless within the thirty (30) days a petition signed by twenty-five percent (25%) of the qualified electors of one (1) of the fire protection districts objecting to the consolidation be filed with the secretary of the district."

# **SUGGESTED CONSOLIDATION TIMELINE / BOARD ACTION FLOW**

## **NOVEMBER 2026 - DECEMBER 2027**

### **POST PROTEST PERIOD**

- If a protest has not been submitted to the District Secretaries by November 11, 2026 then the two Boards will be considered Consolidated, and the timeline below should be considered.

### **NOVEMBER NEW DISTRICT REGULAR COMMISSIONER MEETING**

November 16, 2026 at 6 pm

- Consolidation Agreement Governs
- Monthly Meetings Commissioners both Districts - Nampa (5) + Kuna (5)

### **JANUARY 2027 → DECEMBER 2027**

- 10-Member Transitional Monthly Board Meetings
- November 2027 Elections
  - Subdistricts 1, 3, 5 → 4-year terms and Subdistricts 2, 4 → 2-year terms
